- **Recorded Online Classes:**
All recorded class purchases are **final**. Because access is delivered immediately via

email, no cancellations, refunds, or exchanges are offered.

- **Baked Goods Orders:**

All cake and pastry orders are **non-refundable and cannot be canceled** once confirmed, due to the made-to-order nature of these products.

3.2 Order Changes & Modifications

After an order has been confirmed, any requested changes must be submitted within 48 hours of booking. Once planning, scheduling, and preparation have begun, no further changes can be guaranteed.
